
- Area Directors for their dedication to their chapters and the National Board. We would not be able to support our members without your assistance.

# RECOGNIZING EXCELLENCE WITHIN THE RANKS Don't Forget to Submit Your Applications for These Awards!

### The Distinguished Member Achievement (DMA) Award

The Distinguished Member Achievement (DMA) Award was established in 1988 to recognize outstanding individual achievement in the NACM Credit and Financial Development Division. The candidate must be a CFDD member for a minimum of five years and have held at least two offices including chairman of two different committees. This award is acknowledged during the CFDD luncheon at the NACM Credit Congress. *One entry per chapter.* 

### **Marilynn Daugherty Spirit Award**

The Marilynn Daugherty Spirit Award is judged annually by the MDSA Selection Committee, but is only awarded when the committee feels an individual merits such an honor. Anyone can submit a candidate for this award. The candidate must be a CFDD member for a minimum of eight years and currently a member in good standing. The judges will focus on participation in and promotion of CFDD and the credit profession, candidate dedication, character and integrity. This award is acknowledged during the CFDD luncheon at the NACM Credit Congress. *One entry per chapter*.

### **National Mentor Achievement Award**

This award was established to recognize outstanding achievements by a CFDD member in the field of mentoring. The CFDD National Mentor Achievement Award is judged by the Mentor Award Committee, but is only awarded when the committee feels an individual merits such an honor. Any CFDD member or chapter may submit a candidate for this award. The candidate must be a CFDD member for a minimum of five years and must have completed the CFDD Mentor Training Program. A letter of recommendation from an individual or chapter and testimony(ies) of mentee(s) must be attached to the application, along with a biography of the candidate, including:

- 1. Their participation in and promotion of the credit profession and CFDD through the mentoring process;
- 2. The achievements of those mentored; and
- 3. Their dedication, character and integrity.

This award is acknowledged during the CFDD luncheon at the NACM Credit Congress. One entry per chapter.

### **CFDD National Regular Program Award**

In recognition of outstanding chapter programs, CFDD National presents one award in each membership size classification in the category of Regular Monthly Meeting. Applications must be completed and signed by an authorized representative of the chapter. Awards are acknowledged during the CFDD luncheon at the NACM Credit Congress. *One entry per chapter.* 

### **CFDD National Special Program/Seminar Award**

In recognition of outstanding chapter programs, CFDD National presents one award in each membership size classification in the category of Special Seminar/Workshop. Applications must be completed and signed by an authorized representative of the chapter. Awards are acknowledged during the CFDD luncheon at the NACM Credit Congress. *One entry per chapter.* 

### **CFDD National Publicity Award**

In recognition of outstanding chapter publicity, CFDD National presents one award in each membership size classification. Applications must be completed and signed by an authorized representative of the chapter. Awards are acknowledged during the CFDD luncheon at the NACM Credit Congress. *One entry per chapter.* 

The annual event to recognize and honor excellence among CFDD members is rapidly approaching. All awards will be given at CFDD's 2014 Awards and Installation Luncheon on June 10, 2014 during the 118th Credit Congress in Orlando, Florida.

Now is the time to complete applications for the members and chapters that best exemplify what makes CFDD a professional organization *par excellence*. All national award applications may be downloaded from the CFDD website as Microsoft Word documents. Award applications must be submitted to CFDD by email on or before Monday, March 17, 2014.

# **Doing More with Less: Six Simple Tips!**

"Most people ask for happiness on condition. Happiness can only be felt if you don't set any condition." ~ Arthur Rubinstein

Could you use tips on how to be more efficient and effective — how to just get *things* done by doing more with less! Implement these six simple techniques immediately and watch your productivity soar:

1. **Practice patience and perseverance.** In this age of mobile phones, tweeting and texting, it's easy to want what you want when you want it—and that's *now*. It isn't only two-year-olds who demand instant gratification. It seems no one is willing to wait anymore. Yet, whether it's vying for a promotion at work or starting a business on the side, anything worth accomplishing still requires perseverance and patience.

As I ran behind a fellow jogger while on the shores of Lake Michigan a few summers ago, I read the slogan on the back of her t-shirt and still remember the message. It read "Miracles Require a Lot of Hard Work." What a great reminder!

- 2. Discover how to overcome procrastination once and for all. Doing this will help you get, and stay, motivated. Why? Studies show that the longer you procrastinate, the harder it becomes to get started. I believe that, deep down, most people know what things will improve their lives but put off *doing* them. Whether it's getting rid of extras in the closet, sorting through the desk drawer or cleaning up your eating habits, don't wait. By procrastinating, you "clutter" your mind further by thinking about what you *should* be doing. If you can't do it now, make a plan. And follow it!
- 3. **Stop doing everything yourself.** Even if it means hiring a high school student to do the menial tasks, do it. I know what you're thinking. "If I want it done right, I have to do it myself." Or, "In the time it will take to train someone, I could finish it." Yes, you *can* "do it all," but only for so long. Eventually, the stress *will* catch up to you and you could find yourself spending more time accomplishing less. Delegate!
- 4. Edit your to-do list. As my mother used to say, "Take it in baby steps." If you must do everything yourself (and these days, few organizations are replacing people who leave), at least do *some* of the work right away. At a minimum, commit to what you will accomplish today both in writing—and verbally—to someone you trust. Then, step back and cut down your "to-do" list the best you can. If you select two projects to finish by a certain time, do them to the best of your ability rather than rush through four projects and not be happy at the end! Why? Studies show that due to unforeseen interruptions, it takes 25% longer to complete a project than you think it will. So, don't beat yourself up. Instead, be realistic about what you can get done today.

No matter the number of projects on your plate, do this: Move everything off your desk except the one you're working on. Then, concentrate on it single-mindedly. Give it the full attention it deserves. After it's done, proudly strike it off your list!

5. **Practice positive thinking.** I read that the number one thing people want to change in the New Year is adopting a more positive attitude. Consider this: Your thoughts lead to words; your words lead to actions; your actions determine your approach to your relationships, career, family and everything else. So think about what you're thinking about, whether it's positive or negative. Then pick positive!

I confess to being a worrier. How ironic since part of my job is helping people become more productive, positive and patient with others! I've consistently tried to break my worrying habit and 90% of the time I'm able to pause and ask, "What's the best that can happen?" Doing this works! After all, worrying is wishing for what you *don't* want. Plus it doesn't solve anything nor does it add a single day to your life. Again, become aware of your thoughts. Your reward? People like being around you!


6. Eat healthy foods and exercise to feel happy. Studies have shown that junk food produces junky, negative thoughts. When you feel better physically (and exercise gets those endorphins going), you become happier mentally. See your doctor to find out what kinds of vitamins and minerals you should be taking. Start your morning with protein for mental acuity and to stabilize your blood sugar. Increase your daily intake of fruits and vegetables. Drink more water. If you're under a time crunch (who isn't these days), grab raw nuts such as almonds or pumpkin seeds for protein and iron. And keep moving!

Bring these six new habits into your life and you'll accomplish your goal of doing more with less every day!

# **Area Director Responsibilities**

CFDD National Board Elections are held each year at Credit Congress. To be eligible to run for a CFDD National Director position, candidates must be employed by a firm holding membership in NACM, be actively engaged in the credit or financial field and be an active member of a CFDD chapter or a Direct National Member. Area Director responsibilities include:

- Acting as liaison to assigned chapters and members and also as a liaison to the NACM National Board.
- Offering assistance and guidance to officers and members of your assigned chapters. Maintaining contact throughout the year with chapter presidents and submitting quarterly reports on chapters to CFDD National.
- Communicating any news from CFDD National to chapters. Reminding chapter presidents of upcoming deadlines for national scholarship and award applications, national newsletter submissions, etc. Offering assistance with completion of national scholarship and award applications.
- Attending Credit Congress, including the CFDD Board Meeting, CFDD Awards and Installation Luncheon and the CFDD Board Organizational Meeting.
- Attending the CFDD National Conference and CFDD Board Meeting. Preparing a report on chapters to be presented at the Conference Business Meeting.

- If possible, attending at least one meeting of each assigned chapter per year.
- Helping your chapters set and meet goals for membership.
- Offering educational program suggestions for meetings and seminars.

Members interested in serving as an Area Director on the CFDD National Board are asked to submit their applications for Area Director by April 1. Candidates will have an opportunity to be interviewed by the Nominating Committee during the CFDD Board Meeting at Credit Congress on Sunday, June 8, 2014. If a candidate is unable to attend Credit Congress, the Chairman of the Nominating Committee will make arrangements for an interview by conference call. # **New National Programs**

### Leadership

This module highlights task management and influencing others. The task management segment covers goal setting and problem solving techniques, while the discussion on influencing others defines time and resource management. You will learn how to eliminate barriers to your employees' top performance. The keys are training, communicating with your staff, learning to develop interpersonal skills and the nine strengths of great leadership. Also important is learning that influence is not manipulation and what the difference is.

This module is great for the beginner or experienced manager as a review of what works and what blocks success personally for you or your team.

This information is an excerpt from the PowerPoint presentation on Leadership, one of the six modules in the new professional development series. Other topics include: Developing Successful Mentoring, Cultivating Talent, Business Etiquette, Effective Relationships and Interview and Hiring. # **Notification of a Dues Increase**

In 2011, The CFDD National Board unanimously voted for a National dues increase. Rather than imposing a larger increase in dues at one time, it was decided, after some discussion, that dues should be raised in smaller increments over the subsequent four years. In accordance with that decision, CFDD National dues will increase \$2.50 per member in 2014. The chapters will be billed \$72.50 per member reported and direct member dues will be \$82.50.

Each chapter has the ability to pass along this increase to their membership, or decide to cover the cost. This is strictly a CFDD chapter board decision. If you have any questions regarding the dues increase, please feel free to contact any member of the CFDD National Board.

### **MEMBERSHIP CAMPAIGN CONTINUES**

The 50% discount on membership dues will again be offered for new members reported through June 30, 2014. Membership chairmen and chapter presidents have been notified about this year's membership campaign. Spread the word to other credit professionals who may not know what benefits they and their companies will receive from membership in NACM and CFDD. Education, networking and professional development are all part of the offering. There will be an award for the individual member and the chapter that recruits the most new members.
