





It goes without saying that obtaining your designations is not easy, nor is it meant to be easy. There are hours of studying, testing and reviewing before tests, but the end results speak for themselves.

The increased knowledge, elevated confidence level and recognition in the credit and finance field are just a few of the benefits you will receive. Another important plus is how your employer views the benefits that they receive from the knowledge you have gained. Your designation indicates you are both motivated and accomplished. It demonstrates to your employer that you are someone who is both knowledgeable and working to maintain standards within your field. Because of the number of designees within NACM, companies are becoming more aware of the value of hiring a credit professional with a designation. We must continually educate our employers as to the value of our designations and the educational process because we need their continued support.

Professional Designations Enhance Your Growth

We talk a lot about professional designations and proudly have our members announce their designations during meeting introductions. But what does it all mean and what can it do for you?

NACM developed the certification process to help its members continue their professional education and to distinguish their accomplishments in their profession.

NACM continues to actively promote the designations and we now see more companies reference holding a designation in their job searches. It is also up to us to educate our companies about what the designations entail and how they benefit the company as well as the employee. I was once advised that the only thing worse than losing an educated employee was keeping an uneducated one. Our meetings stress educational offerings to enhance your professional growth and you can earn CEU and CCE recertification points that aid you in your designation process.

These designations can greatly enhance your image, your exposure and your marketability in the business world. They can help you to stand out from a field of candidates. There are a number of processes available to help you to achieve these designations, but it is up to you to take that first step and begin the process.

I achieved my first professional designation 21 years ago and it has aided me in both my personal and professional growth. Since maintaining the CCE designation requires achievement of both educational and participation points, I was further encouraged to participate in educational offerings and become an active participant in our National and local chapter activities. My company is well aware of my educational pursuits and its opinion of me as a professional is enhanced because of this. It actively encourages my local and national professional activities because it is understood that these pursuits make me a better employee who is continuing to develop a wider range of understanding about how to best accomplish my job. I proudly use and announce my professional designation, because it demonstrates my commitment to myself and if someone is unaware of it, I get the opportunity to explain not only what it means, but also what it takes to achieve and maintain it. Do not underestimate what your company notices in you and what your independent efforts to enhance your growth will give you.

Professional Designations Are an Investment in Your Career

Earning your credentials through NACM is one of the best investments you can make in your career. It can help you land a better job, a promotion at work and the recognition from your supervisor and peers. NACM's *Business Credit* magazine had an article in their November /December 2008 issue where it was shown that designation holders earn more than non-designation holders. It is worth your time to invest in yourself.

I am an instructor for Forius, the NACM Affiliate in Minneapolis/St. Paul. I teach the Business Credit Principles course and am a substitute teacher for the other classes in the Credentialing Program. I also co-teach the study sessions before the exams. I really enjoy teaching. Not only does it help me remember the basics of credit, but I also learn so much from the students.

My preparation takes about six hours for a three-hour class. I read the book to make sure I cover the material in class. I prepare notes so I do not forget important points the students must know. I try to bring real-life examples, as I believe this helps the students remember the material. I encourage students to participate, as many of them have great examples on how they have used the material in their jobs. The discussion makes the class better for the students as well as the teacher.

I let the students know the material that is covered in the exam. The Business Credit Principles exam is true/false and multiple choice.

I always let them know they will have plenty of time to complete the exam. I suggest they go through the test and answer the easy questions first. They can always go back and answer the ones they left unanswered. Sometimes a question later in the exam will help them remember an answer to a question at the beginning of the exam.

The exams are not easy and they must study if they want to pass. One reason is to make sure the students are prepared for the CBA, CBF and CCE exams, as they are not easy tests. The other reason is so the students can take this information back to their employer and show them that the time and money was worth the investment. The students agree that the questions are fair.

Forius holds a study session for students taking the CBA, CBF and CCE exams that I co-teach with Jeff Hawkins, CCE. We cover the material on the exams and ask them questions such as "What is a Current Ratio? Does the Truth-in-Lending Act pertain to pricing?" Jeff and I want to make sure the students are prepared and feel they can pass the exam.

NACM offers the exams four times a year. They are held in March, July, and November and are administered at your local NACM Affiliate office. You can also take the exam at Credit Congress.

To get started, you should register with your local NACM Affiliate for the CAP Program. The first class is Business Credit Principles. You can also go to the NACM-National office and take the class over one week or attend Credit Congress and take the class.

The other required CAP courses are Accounting and Financial Statement Analysis I. If you have already taken these courses in college, you may submit an original college transcript to waive these courses. However, many people have forgotten some of the basic functions of accounting or some rules may have changed, so you may consider re-taking these courses. The Accounting Class is also offered online through NACM-National.

The ACAP classes are Business Law and Credit Law. They are offered by your local NACM Affiliate and online through NACM-National.

Obtaining your CBA, CBF or CCE designations is not an easy task and does take time, but is worth the journey. I see it on the smiles of the students when they get their certificates.

Marilynn Daugherty Spirit Award

The Marilynn Daugherty Spirit Award will be judged annually by the MDSA Selection Committee, but will only be awarded when the committee feels an individual merits such an honor. Anyone can submit a candidate for this award. The candidate must be a CFDD member for a minimum of eight years and currently a member in good standing. The judges will focus on participation in and promotion of CFDD and the credit profession, candidate dedication, character and integrity. This award will be acknowledged during the CFDD luncheon at the NACM Credit Congress. (One entry per chapter.)

National Mentor Achievement Award

This award was established to recognize outstanding achievements by a CFDD member in the field of mentoring. The CFDD National Mentor Achievement Award will be judged by the Mentor Award Committee, but will only be awarded when the committee feels an individual merits such an honor. Any CFDD member or chapter may submit a candidate for this award. The candidate must be a CFDD member for a minimum of five years and must have completed the CFDD Mentor Training Program. A letter of recommendation from an individual or chapter and testimony(ies) of mentee(s) must be attached to the application, along with a biography of the candidate, including:

- 1. Their participation in and promotion of the credit profession and CFDD through the mentoring process;
- 2. The achievements of those mentored; and
- 3. Their dedication, character and integrity.

This award will be acknowledged during the CFDD luncheon at the NACM Credit Congress. (One entry per member or chapter.)

CFDD National Regular Program Award

In recognition of outstanding chapter programs, CFDD National presents one award in each membership size classification in the category of Regular Monthly Meeting. Applications must be completed and signed by an authorized representative of the chapter. Awards will be acknowledged during the CFDD luncheon at the NACM Credit Congress. (One entry per chapter.)

CFDD National Special Program/Seminar Award

In recognition of outstanding chapter programs, CFDD National presents one award in each membership size classification in the category of Special Seminar/Workshop. Applications must be completed and signed by an authorized representative of the chapter. Awards will be acknowledged during the CFDD luncheon at the NACM Credit Congress. (One entry per chapter.)

CFDD National Publicity Award

In recognition of outstanding chapter publicity, CFDD National presents one award in each membership size classification. Applications must be completed and signed by an authorized representative of the chapter. Awards will be acknowledged during the CFDD luncheon at the NACM Credit Congress. (One entry per chapter.)
