Chapter Spotlight: Portland

CFDD Portland, which serves northwest Oregon and southwest Washington, has a long and interesting history and track record of success in providing education and scholarship opportunities for its members.

In 1896, the Portland Association of Credit Men (PACM) was founded. Women participated in activities, but not as official members. In 1931, the Women's Chapter of the Portland Association of Credit Men was organized and officially recognized, and Ruth Gooch was installed as its first chairman.

1934 was a hallmark year. The Women's Chapter sent its first representative to attend a Northwest Creditmen's Conference, PACM began to routinely appoint credit women to standing committees (two women were on standing committees in 1931 and by 1936-1937, the number had grown to 27) and Portland member Elisabeth Moorman, second president of the chapter, was appointed to the National Credit Women's Executive Committee.

In May of 1960, the PACM changed its name to Oregon Association of Credit Management (OACM), while the Women's Chapter remained the Portland Credit Women's Group (aka Credit Women's Group). In 1981, the Credit Women's Group began to allow male membership; in 1985, the chapter became Portland Credit Career Group and in 1988 became Credit Financial Development Division (CFDD) Portland.

Jeff O'Banion, CCE, CICP, who was CFDD National Chairman 2006-2007 and a 2007 Class A National Distinguished Member Award recipient, joined the Portland Chapter in 1981 and was the first male member of the Credit Women's Group/CFDD Portland.

Here are some Portland Chapter 2007 highlights:

- Recognized for 25 years service: Jeffrey O'Banion, CCE, CICP, Northwest Natural Gas; Nancy Reed, CCE, Lampros Steel; Lourdes (Lou) Rice, Pacific Metal.
- Elected to NACM Oregon Foundation Board: Jeffrey O'Banion, CCE, CICP, chairman; David Erickson, CCE, vice-chairman; Lourdes Rice, director; Betty Beeson-Bauder, CBF, director; Alice Campbell, CBF, CICP, Director; Charlene Gothard, director.
- Awarded \$4,045 in scholarships, a 95% increase from 2006 when awards totaled \$2,075.
- The Portland Chapter currently has 79 registered members, of which, we are proud to say, 25 are professionally certified — 13 CCEs, 6 CBFs, 8 CBAs and 4 CICPs.
- In addition to fund raising events and attending the Pacific Northwest Credit Conference (thank you, Tacoma Chapter), monthly educational meeting topics included bankruptcy update, sales tax, time management, leadership skills, a question and answer presentation by an expert credit panel, credit scoring and fraud investigation via the Internet.

A monthly newsletter, *Creditline*, has been published since the days of the Credit Women's Group and is used to keep members informed of upcoming events, member success, education and scholarship opportunities, stay abreast of news impacting the credit market and to share special events and bits of humor. Thanks to the continued support of NACM Oregon, under the direction of Rod Wheeland, CCE, CAE, existing and potential members receive *Creditline* via email at no charge.



Our current dynamic officers and directors are: Marilyn Rea, CBF, Pacific Architectural Wood Products, president; Diane Snyder, CCE, Rodgers Instruments, vice president; Skip Dailey, Schnitzer Steel Industries, secretary; Jeffrey O'Banion, CCE, CICP, Northwest Natural Gas, treasurer; Jessica Lankford, Quimby Corp, 1 year director; Ruth Moehnke, Columbia Steel Casting, 1 year director; Nita Fritzler, United Tile, 2 year director; Jackie Maze, Cadet Manufacturing, 2 year director; and Charlene Gothard, Land O' Lakes Purina Feed, chairman of the board. Sandee Texley, CCE, Bowtech, is the area director.

The Portland Chapter continues to work with CFDD National, NACM Oregon and other CFDD chapters to fulfill CFDD's goals of promoting the interests of credit professionals, fostering credit management as a career, encouraging credit education, providing opportunities to discuss problems affecting credit, building confidence in business relations, networking with other credit professionals, working with civic and national bodies and encouraging friendship among credit professionals.

We're looking forward to 2008 being another great year!

Education: The Foundation of CFDD

I became involved in CFDD in the mid 1990s, shortly after I took a position as credit supervisor for a manufacturing company and started looking for ways to improve my knowledge of credit management. Most of what I knew I had learned on my own by asking lots of questions of my local NACM affiliate. NACM was a great source for information and tools and also offered occasional local seminars on relevant topics, but I wanted more. I wanted to learn from people who experienced what I did on a daily basis. I wanted to develop a network of credit professionals who would be able and willing to provide guidance and expertise relative to any situation I might face on any given day. With CFDD, I found all that and more.

What I found through membership in CFDD was a close knit group of individuals who were extremely knowledgeable, helpful, encouraging and supportive. The more experienced members of my local CFDD group mentored me and provided opportunities for me to learn and grow through involvement in the local chapter. I have held positions as secretary, member-at-large, vice president, president, and have also been on various committees throughout the years. My mentors encouraged me to take advantage of the many educational opportunities provided by NACM and CFDD. I attended the Credit Management Leadership Institute and countless local, regional and national CFDD and NACM conferences and seminars. With support and encouragement, I ultimately obtained my Certified Credit Executive (CCE) designation.

Because I have benefited so much from my involvement in NACM and CFDD, I try to give back and mentor others who may be just like I was all those years ago. I currently serve on the Board of Directors as chairman for NACM-Ohio. When the Cincinnati chapter of CFDD folded, I joined the Dayton chapter and drove an hour each way to continue my participation. I have had the pleasure of serving as an area director on the CFDD National Board of Directors. I am also an instructor for our local CAP and ACAP classes and I always encourage my students to become involved in CFDD and NACM. Each role that I filled within the local chapter has helped me to grow both personally and professionally, and I have become more knowledgeable, more confident and a better rounded individual with each accomplishment.

I have changed jobs several times since I became a member of CFDD, and I can say with certainty that my involvement in both NACM and CFDD has been a strong selling point with new employers. Additionally, my CCE designation has helped me to advance faster, and with greater rewards, than I ever could have imagined. Each time I changed jobs, I was given greater responsibilities and I was rewarded with an average 20% pay increase with each new position. My current salary is two-and-a-half times what it was when I first joined CFDD. I went from a supervisor of one to managing a department of 26 people.

I am not naïve enough to think that my involvement in NACM and CFDD and my CCE designation are solely responsible for the career

advancement that I have been fortunate enough to achieve. However, I know without a doubt that I would not have obtained the knowledge and the experience that has gotten me where I am today if I had not participated in these wonderful organizations. I cannot stress enough how important it is for everyone to take advantage of the educational and networking opportunities that are presented to you as a member of CFDD. The cost of membership is minimal compared to the rewards that could be realized.

As credit managers, we are very aware of the continually changing environment in which we operate. If we don't change with it, we won't survive. What better way to change than to embrace all that CFDD has to offer? Become involved and continue your education so that you have the chance to learn, grow, and change your future. The opportunities are endless.

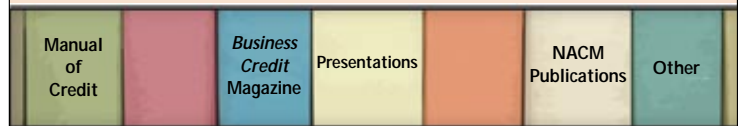
Member Viewpoint
